# Prudence Lodge No 100 AF&AM

Annual Dues .....  
Perpetual Membership 20 x Annual Dues.....

1. The current years dues must have been paid before starting this plan.

2. Members may make annual, quarterly, or monthly payments.

3. All monies collected will be deposited in a special "Membership and Memorial Account" and held until the contract is paid in full, then the funds will be withdrawn and used to purchase a Perpetual Life Membership through the Grand Lodge AF&AM of Kansas.

4. Should a member default by failing to make scheduled payments for 3 consecutive months, or two consecutive quarters of one year, Prudence Lodge No 100 will deduct the dues and per capita tax which had been waived during the payment period, and return the remainder of the accumulated funds to the member. The member may elect to leave any remainder in his account to pay future dues, or to be applied toward a re-instated perpetual life membership, but must continue paying dues as a regular member until the payment plan is completed.

5. A member may choose to withdraw from this plan at any time, but upon withdrawal, the amount of dues and per capita tax waived will be deducted and the member refunded any balance.

6. The Secretary/Treasurer will deposit monies collected in a separate account administered by the Lodge and will maintain computerized records for each participating member, furnishing receipts after each payment.

1. Dues for the year 200\_\_ must be paid up

2. Methods of Payment:

a) Three annual payments of \$ \_\_\_\_\_ each payable prior to Dec 15th, 200 \_\_, 200 \_\_, and 200 \_\_.

I understand that the payments made will be deposited in the

Special Membership and Memorial account of Prudence Lodge #100, administered by the Secretary and Treasurer of Prudence Lodge; that I will not be billed for annual dues as long as I maintain the payment schedule; that during my lifetime, I will not be subject to future dues increases or assessments, and that when my contract has been paid to Prudence Lodge #100, a Perpetual Membership, in my name, will be secured with the Grand Lodge, the earnings of which will benefit my Lodge, forever.
